Introducing quality assurance frameworks in vocational education and training (VET) has become a priority in recent years. VET providers at the early stages of developing their quality assurance approaches can learn from the experiences of others who have already implemented comparable quality frameworks.

The EQAVET network has identified a series of common themes, called building blocks, which have been used by European VET providers to establish and strengthen quality assurance processes, in particular the approaches set out in the European Quality Assurance Reference Framework (the EQAVET Framework). The building blocks present an early analysis of approaches to quality assurance among European VET providers.

The EQAVET Framework

The EQAVET Framework is designed to promote better VET by providing authorities and VET providers with common tools for the management of quality in VET.

Given the diversity and complexity of approaches to VET quality within and across Member States, the Framework offers a common point of reference to ensure transparency, consistency and portability between the many streams of policy and practice across Europe, in order to increase mutual trust and mobility of learners and workers.

The Framework was developed by Member States in cooperation with the European Commission and adopted by the European Parliament and the Council in 2009. It is a key element in the follow up to the Copenhagen Declaration, which calls for closer cooperation in the field of VET, and in the ongoing work to renew Europe's education and training systems. In every Member country, a *Quality Assurance National Reference Point* gives access to information on the Framework and national quality assurance matters in VET.

Building Blocks

The early analysis of approaches to quality assurance by VET providers across Europe, which are in line with the EQAVET Framework, has identified six interdependent building blocks. These six building blocks support and complement each other and build on the EQAVET indicative descriptors and indicators.

The building blocks provide guidance by identifying key activities which could be undertaken in order to improve quality assurance processes in line with the EQAVET Framework. The building blocks set out activities that would help VET providers to develop and support a quality assurance approach in line with the EQAVET Framework. They include:

- referring to the EQAVET quality assurance cycle
- a “call to action”
- identifying the key issues that should be considered and the factors for success
- referring to “lessons learnt” based on an analysis of recent experiences from European VET providers, which suggest new ways forward

Suggesting new ways forward

1. Ensure there is a management culture which is committed to quality assurance

How can the management team:

- provide leadership in quality assurance?
- ensure a culture of quality assurance which includes learning from the experiences of others?
- encourage staff involvement in quality assurance?
- ensure a cost effective and appropriate approach to quality assurance?

The EQAVET Framework can be used by the management teams of individual VET providers to monitor and build a quality assurance approach.

External recognition of effective quality assurance systems helps to motivate and encourage managers and staff.

Central to the implementation of the EQAVET Framework is a culture which supports and values quality assurance.

Does the management team value quality assurance?

Are all managers involved in ensuring high quality VET?

Does the management team take responsibility for quality assurance?

2. Develop approaches which reflect the provider's circumstances

What should VET providers consider when developing their approach to quality assurance?

How can VET providers use what they learn from the experiences of others?

How can Quality Assurance National Reference Points help VET providers ensure their approach is in line with the EQAVET Framework?

A consistent approach to high quality training and the outcomes of training helps business and VET providers to improve their competitive advantage.

VET providers often have a long tradition of quality assurance; success is easier if this experience is used as a basis for further development.

An incremental approach which makes the introduction or strengthening of quality assurance manageable can produce significant improvements.

5. Use data and feedback to improve VET

How can VET providers benefit from using the EQAVET indicators?

A systematic and consistent approach to collecting, analysing and using data provides a more secure way of making decisions in relation to VET provision.

What does the Building Block mean?

The 'call to action'

VET has to meet the needs of both employers and learners. Key to any quality assurance system is the way data on performance is systematically collected and used by VET providers to modify and improve provision.

Is data and feedback analysed and used to improve VET provision?
Do the EQAVET indicators and indicative descriptors help to identify areas for development?

How can VET providers:
- decide what data is relevant?
- identify sources and collect data?
- analyse the data?
- use the data to improve quality

The views of learners, teachers, trainers and employers are essential to improvement.

Transparency helps everyone understand what changes are required – this supports quality improvement.

6. Ensure VET is based on the involvement of external and internal stakeholders

How are internal views on the quality of VET taken into account?

Providing for the needs of employers is essential in VET.

What does the Building Block mean?

The 'call to action'

VET is based on effective partnerships between government, social partners and national stakeholders; employers and VET providers; and learners and society. They create the foundation stone of the VET system which gives it strength, relevance and acceptability.

Is the quality of provision improving as a result of stakeholder feedback?
How are the internal and external views taken into account?
Is there a systematic approach to ascertaining and meeting the needs of stakeholders?

How do you collect and take into account the views of key external stakeholders?

Collaboration, both within regional and national associations as well as between similar organisations, can develop better quality assurance processes.

What can be learnt from your competitors or from other VET providers?

Main messages

- The EQAVET Framework reflects existing quality assurance arrangements used by VET providers.
- There are many diverse ways of introducing quality assurance approaches which reflect the EQAVET Framework.
- Many VET providers have developed their own quality assurance systems which are efficient, cost effective and well respected.
- Progress towards the EQAVET Framework and other European tools is being made by many VET providers.
- Increasing business competitiveness is dependent on high quality staff, and quality assurance can make a significant contribution.
- Monitoring the quality of teaching and learning is an important aspect of quality assurance. Data and feedback after the teaching and learning have been completed is not enough.
- The management and leadership team have a crucial and central role in quality assurance and in ensuring that VET meets the needs of the labour market.
